



Neighborhood Prosperity Fund



Neighborhood Prosperity Fund

Quick Overview

About: Neighborhood Prosperity Fund incentivizes community development, economic growth, and job creation through the use of local funds to provide financing for projects that attract private investment to distressed communities.

DMPED will fund projects for non-residential/commercial components of a mixed-use project in targeted census tracts greater than 10% unemployment.

Target: Developers with projects in designated Neighborhood Prosperity Fund tracts

Award Range: For FY20 Great Streets Neighborhood Prosperity Fund, a maximum of \$3 million is available for grant funding toward mixed-use real estate projects in targeted census tracts. Funds are only eligible for the commercial component or project. Minimum application request, \$250,000.00.

Timeline: Notice of Funding Availability: July 3, 2020
 Request for Applications: Friday, July 24, 2020 – Friday, August 13, 2020

Quick Overview

About: Grant funds will be used for business model restructuring, business continuity plan, related COVID-19 marketing expenses, and specified operational expenses.

Targeted: Brick-and-mortar businesses located in a Great Streets corridor

Award Range: \$10,000-\$12,000 (pending funding availability)

Timeline: Within next 60 days



Small Business Resilience Grant



How to get ready:

Basic Requirements*

- Must be in a Great Streets Corridor
- Active District of Columbia business license and Certificate of Occupancy
- Have or attain a Clean Hands from the DC Office of Tax and Revenue before grant funding;
- Have been revenue-generating for at least three (3) months prior to the declaration of the COVID-19 Response Emergency Amendment Act of 2020;
- Generate less than \$3,000,000 in revenue annually;
- Demonstrate a loss of revenue
- 2018 or 2019 Tax Returns or EIN Letter

Quick Overview

About: The purpose of the grant program is to support existing small businesses, attract new businesses, increase the District's tax base, create new job opportunities for District residents, and transform 13 emerging commercial corridors into thriving and inviting livable, walkable, and shoppable neighborhood centers.

Targeted: Brick-and-mortar businesses located in a Great Streets designated corridors

Award Range: up to \$50,000

Timeline: Within next 60 days

Great Streets Small Business Retail Grant



Are you Great Streets Ready?

- Have a business that is located within or along the border of a Great Street corridor
- Be in Good Standing with the DC Department of Consumer and Regulatory Affairs (DCRA), the DC Office of Tax and Revenue (OTR), the DC Department of Employment Services (DOES), and the federal Internal Revenue Service (IRS)
- Have an active Basic Business License
- Evidence of site control
- Possess proof of property and liability insurance
- Have an active Basic Business License
- Understand the scope of the proposed project (including timeline, costs, project management, and potential impact to the business, corridor, and community)
- Have financial records readily available
- Understand how to create a project budget and financial projections

\$2,190,000	To implement the "Tipped Wage Worker Fairness Amendment Act of 2018"


